



FREE SHARES WAITING LIST PROMOTION – TERMS AND CONDITIONS

1. BUX B.V. (“**BUX**”) is giving away free shares to the first users that sign up to the BUX Zero Waiting List (“**Waiting List**”) on the BUX website, and who subsequently open an investment account in the BUX Zero investing app (“**BUX Zero app**”), under the conditions specified below.
2. To qualify for this promotion you need to:
 - a. Sign up for the Waiting List on the BUX website;
 - b. Accept the terms & conditions for the Free Shares Waiting List Promotion (“**This Promotion**”) and Marketing Consent while subscribing for This Promotion on the BUX website;
 - c. Open an investment account in the BUX Zero app once the app is available in the Apple App Store or Google Play Store;
3. This offer is limited to the first 100,000 users that register for This Promotion and subsequently open an account in the BUX Zero app.
4. If you are selected to receive a share, you may receive a share in the BUX Zero app within a maximum of fifteen business days after opening an investment account in the BUX Zero app.
5. Shares may also be distributed amongst users that have invited friends to the Waiting List.
 - a. Invited friends need to have subscribed to the Waiting List and need to have opened an investment account in the BUX Zero app;
 - b. Users that have invited a friend, that subsequently also opened an investment account in the BUX Zero app, may receive one additional share for every friend invited, dependent on availability;
 - c. If you are selected to receive one or more additional shares for inviting friends, you will receive these share(s) in the BUX Zero app within a maximum of fifteen business days after the criteria in articles 4a and 4b are met.

8. You are only eligible for This Promotion once. If you have signed up for the waiting list multiple times and you have created multiple accounts in the BUX Zero app, only the first opened investment account is eligible to participate. The other accounts are excluded from participation.

We will notify you of any changes to This Promotion and/or its conditions by updating our website and we recommend that you check our website regularly for such updates.
