



Seedrs Campaign: BUX Crowdfunding Tier Perks - Terms & Conditions

1. BUX Holding B.V. ("BUX") is giving away several gifts ("Perks") for people who invest in BUX via Seedrs platform during the 2022 crowdfunding campaign ("This Promotion") under the conditions specified below.
2. To qualify and be eligible to receive the Perks you need to:
 - a. Have invested at least the minimum amount as stated in the Tiers below:
 - i. Tier 1 - € 500- € 1,000;
 - ii. Tier 2 - € 1,001-€ 5,000;
 - iii. Tier 3 - € 5,001- € 20,000;
 - iv. Tier 4 - € 20,001 +, and;

 - c. Have an account with BUX Zero Investment app (have completed the onboarding process and be accepted as a BUX Zero Client), and;
