



Temporary Free Shares Promotion – Terms and Conditions

1. BUX B.V. (“BUX”) is giving away free shares to users that refer new users to the BUX Zero app using their personal invite link and who subsequently open an investment account in the BUX Zero investing app (“BUX Zero app”), under the conditions specified below.
2. To qualify for this promotion you need to:
 - a. You have received an email regarding This Promotion and you are a BUX Zero customer in the Netherlands
 - b. Have an active investment account in the BUX Zero app created after 11-10-2021
 - c. Have accepted the terms & conditions for the Free Shares Promotion (“This Promotion”) and Marketing Consent while subscribing for This Promotion on the BUX website;
 - d. The new user (referral) who used your personal link to install the BUX Zero app must also accept the terms and conditions, accept the Marketing Consent and have a funded investment account with the BUX Zero app
3. If the above conditions are met, you may receive a share in the BUX Zero app worth approx. the sum of €9 within a maximum of fifteen business days after the new user, whom you have referred, has opened an investment account in the BUX Zero app.
4. Your referral also receives a share worth approx. the sum of €9 within a maximum of fifteen business days after the new user opened an investment account in the BUX Zero app. Your referrals will not benefit from your increased rewards at the 3rd and 5th referral.
5. The value of the share differs per invited new user (successful referrals):

1 share	1 share	2 shares	1 share	3 shares
€9	€9	€18 (2x€9)	€9	€27 (3x€9)

6. The maximum number of shares that you can receive in total as a user is 10 shares. With your 3rd and 5th referral you may receive two (2) and three (3) shares respectively, but for the intent of this promotion these shares will be counted as ‘one’ (1) share towards your maximum of ‘10 shares’ for referrals in accordance with This Promotion.
 - a. Therefore you may repeat the above pattern mentioned in clause 5. once more after initial completion.
7. The 3rd and 5th referral rewarded shares are distributed by rewarding 2 or 3 shares valued around €9 for the 3rd and 5th referral respectively.

8. Shares that may be distributed are decided in full discretion by BUX only and are non-negotiable.

BUX reserves the right to withhold any prizes for which a participating user is selected if BUX is of the opinion that the spirit of This Promotion is being abused or irregular patterns are being observed. BUX will resolve any disputes, whether or not covered by these conditions, in a fair and appropriate manner and the decision of BUX regarding a dispute will be final.
