

BUX STOCKS

FREE SHARES PROMOTION - TERMS AND CONDITIONS

1. BUX is giving away a maximum number of 100,000 shares for the first users that sign up for the BUX free commission stock trading waiting list (“**waiting list**”) on the BUX website and that have opened and funded an investment account within the BUX free commission stock trading app (“**BUX Stocks app**”) as well and under the conditions as specified below.
2. To qualify for this promotion you need to:
 - a. Sign up for the waiting list on the BUX website prior to the official app release;
 - b. Accept the terms & conditions and Privacy Policy for the free shares promotion (“**this promotion**”) while subscribing for this promotion on the BUX website;
 - c. Open an investment account in the BUX Stocks app once the app is available;
 - d. Fund your account in the BUX Stocks app.
3. This offer is limited to the first 80,000 users that registered for this promotion and subsequently opened and funded an account in the BUX Stocks app.
4. Due to the phased roll-out for iOS and Android, the allocation of the shares per Operating System (“**OS**”) happens on a 50/50 basis. Therefore, the first 40,000 iOS users that have signed up for the waiting list, and subsequently opened and funded an investment account in the BUX Stocks app, will each receive one share. Similarly, the first 40,000 Android users that have signed up for the waiting list, and subsequently opened and funded an investment account in the BUX Stocks app, will each receive one share as well.
5. If you are on the waiting list we will communicate the actual live date of the different OS versions of the BUX Stocks app at least two weeks before the actual live date by email. Also, the date will be available on the BUX website at least two weeks before the actual live date.
6. If you are selected to receive one share you will receive an entitlement to the share in the BUX Stocks app within a maximum of fifteen business days after opening and funding the investment account in the BUX Stocks app.
7. An additional number of maximum 20,000 shares will be distributed amongst users that have invited friends to the waiting list. These shares will be distributed to these users in a later stage.
 - a. Invited friends need to have subscribed to the waiting list and need to have opened and funded an investment account in the BUX Stocks app;
 - b. Users that have invited a friend, that subsequently also opened and funded an investment account in the BUX Stocks app, will receive 1 additional share for every friend invited, dependent on availability;
 - c. The assessment to determine who is selected for additional shares from inviting friends will happen exactly two months after the OS version of your BUX Stocks app is live. For example, if the BUX Stocks app for iOS goes live on 1 April 2019, then the assessment to determine how many friends you have invited will happen on 1 June 2019. Likewise, if the BUX Stocks app for Android goes live on 1 June 2019, then the assessment to determine how many friends you have invited will happen on 1 August 2019. This way, all your invited friends have two months to open and fund an investment account in the BUX Stocks app;

- d. The division of the additional 20,000 shares per type of OS (iOS or Android) for allocation happens on a 50/50 basis: 10,000 for iOS and 10,000 for Android;
 - e. If you are selected to receive one or more additional shares from inviting friends, you will receive an entitlement to these share(s) in the BUX Stocks app within a maximum of fifteen business days after the assessment mentioned in article 7c;
 - f. The more friends you have invited, the more likely you will receive additional shares as the allocation of the 20,000 shares is based on a ranking where the user that invited most friends will receive most shares;
 - g. The maximum amount of shares that you can receive additionally is five shares per investment account.
8. Once you are notified about being selected for one or more shares, you will first receive an entitlement to the share(s). This entitlement will be added to your investment account in the BUX Stocks app manually.
 9. The entitlement of the share(s) in your account will be transferred to an actual share only when fulfilling the following conditions:
 - a. You have performed at least three open and/or closing trades within the BUX Stocks app;
 - b. You have a balance of at least €1 three months after your first deposit.
 10. The conversion of the entitlement to the share to the actual share would take a maximum of ten working days. This means you will receive the actual share maximum ten working days after fulfilling the requirements as mentioned in article 9.
 11. Shares that will be distributed will be decided in full discretion by BUX only and are non-negotiable.
 12. You are only eligible for this promotion once. If you have signed up for the waiting list multiple times and you have created multiple accounts in the BUX Stocks app, only the first opened and funded investment account will be eligible to participate. The other ones will be excluded from participation.
 13. BUX employees are excluded from participation.
 14. BUX is the sole arbiter of the promotion and reserves the right to alter, amend, extend or foreclose the promotion at any time without prior notice. We will notify you of any changes to the promotion and/or its conditions by updating our website and we recommend that you check our website regularly for such updates.
 15. If BUX detects any form of fraud, abuse or misuse of this promotion of any kind, you will be excluded from this promotion immediately.
 16. BUX reserves the right to withhold any prizes for which a participating user is selected if BUX is of the opinion that the spirit of the promotion is being abused or irregular patterns are being observed. BUX will resolve any disputes, whether or not covered by these conditions, in a fair and appropriate manner and the decision of BUX regarding a dispute will be final.
